Slovanský přehled / Slavonic Review

Founded in 1898, *Slovanský přehled / Slavonic Review* is a peer-reviewed scholarly journal, devoted to the history of Central, Eastern and Southeastern Europe. It is published twice a year by the Institute of History of the Czech Academy of Sciences in Prague. The journal accepts articles in English, Czech and Slovak.

Submission Guideliness

Contributions in English should be sent to managing editor Ms. Jana Škerlová (slovanskyprehled@hiu.cas.cz, skerlova@brno.avcr.cz) as e-mail attachments. Either American or British spelling is acceptable if consistently applied throughout the text. Submitted articles should include an abstract (up to 1,200 characters), summary (up to 1,800 characters) as well as three or more key words.

Technical Requirements for Contributions Submitted:

- Font to be used: Times New Roman

- size: 12

- alignment: flush-left, non-justified

- line spacing: 1.5

- reference style: footnotes, Times New Roman font, size 10, 1.5 line spacing

- references in the text are to be inserted by means of the command "insert" and "footnotes", so that the footnote numbers in the text as well as under the line are automatically indicated in the form of a superscript
- insert footnotes after punctuation marks
- do not use automatic text editing (hyphenation, content generation, live headers, styles, image insertion, etc.)
- between words and after punctuation marks (also in dates, names and abbreviation) only one-keystroke spaces
- indent paragraphs with the tab key (not by typing blank spaces)
- use the "enter" key only at the end of paragraphs, not at the end of each line

Formal Specifications for Visual Attachments:

Submit visual attachments in the required digital image quality; i.e.: **300 dpi** for A5 format (half-page) / A4 (full page), line drawings 600 dpi. Select your resolution with consideration for any necessary cropping, enlargement, etc. Provide attachments in either .tif /.jpg format. Do not submit images inserted into Word or PowerPoint files. When using the pdf format only print data are usable (resolution in dpi points: 2400 or 1200). Image attachments are necessary to be clearly marked with information that makes it clear where they are to be placed in the text, and it must be indicated within the study itself where the attachments are to be placed.

Graphs must be provided in source data formats (for example, Excel). The same holds true for tables and any kind of images with texts (for example, in programs like Corel Illustrator). The

text must be editable; i.e.: we have to be able to fix it. However, always provide the definitive version of all attachments, upon which no further edits should be needed.

When printed photographs are submitted it is necessary to indicate whether they should be cropped, and in that case, in which places, and how large the photograph should be (whether it should take up a half page or a full page).

If you need to insert graphs, visual material and tables into the text, please consult ahead of submission with the editors. Articles should not exceed 25 pages, including footnotes, abstract and summary. Book reviews (*recenze*) should contain 3-5 pgs, book reports (*zprávy*) 1-2 pages. Book reviews and reports should include ISBN or ISSN of the reviewed work. For transliteration from Cyrillic and other scripts, use the Library of Congress romanization table, see (http://www.loc.gov/catdir/cpso/roman.html). All sources should be indicated in footnotes, not in a separate bibliography. Citations should follow Chicago Manual of Style – humanities style. For details and practical examples, see

(http://www.chicagomanualofstyle.org/tools_citationguide.html) or the latest printed edition. Please write the last names of authors in capital letters. Authors of accepted texts will receive proofs for proofreading.

During the first citation of archive material always state the full name and location of the archive and then in parentheses the official abbreviation of the archive if the citation is repeated.

If you are making a citation of archive documents from published editions in which documents are numbered, it is necessary to state the name of the edition, document number, the name of the document and its page numbers – example:

The Political Programmes of Czech National Parties 1860–1890, No. 21, *Palacký's Idea of an Austrian State*, pp. 83–105.

Interviews / Field Research

Name of the informant (or anonymized identity e. g. pseudonym, initials etc.), interview, place of interview or participant observations, date of interview (at least month and year if not exact date). Other characteristics and details if applicable.

Examples (variations)

Elvedin Avdić (pseudonym), interview, Srebrenica, July 13, 2018. Born 1986, survivor of Srebrenica genocide, self-employed. Field notes held by the author.

Armin Ibišević (pseudonym), informal conversation and interview, Srebrenica, May 2014. Approx. 60 years old, survivor of Srebrenica genocide, postman. Audio recording held by the author.

Jaša Alfandari, interview, Podgorica, November 24, 2017. Chairman of the Jewish Community of Montenegro, 71 years old. Field notes held by the author.

GR (pseudonym), informal conversation and participant observation, Ulcinj, September 30, 2021. Café and hotel owner, cca 50 years old. Field notes and photographs held by the author.

Numbers, names and data

Numbers from one to ten, and further whole tens (e.g. twenty) and hundreds (two hundred) should be written in words. Write thousands and millions in the following manner: five thousand, thirty thousand, 76 thousand, 839 thousand, four million, 635 million, etc. Write other whole numbers without dots and dashes, and tenths with a decimal point. When mentioning measurements, do not use abbreviations but entire words (litres, metres, kilometres, hectares, quintals, etc.). An exception is the abbreviation km2 (square kilometre). Do not abbreviate the words "year" and "century." Write "19th century," "in 1932," not "19th cent." or "in the y. 1932." Decades can be written using numbers, e.g. "the 1920s." Use the full name of each month, e.g. "March 15," not "15/3." Do not use italics in the text; italics are intended solely for the names of books or periodicals in the footnotes.

Write out the full names of persons mentioned in the text when they first appear, i.e. the entire first name and surname. Include biographical data in parentheses, e.g. "(1850–1937)."
